- Q. Does every family member receive a card?
- A. Each household will receive two key tags for the whole family to use. These cards are different from your CVS Caremark benefit ID cards and will be mailed separately.
- Q. Is my CVS Caremark ID number printed on the ExtraCare Health Card?
- A. No. Your ExtraCare Health Card has its own ID number printed on the card.
- Q. Do CVS Pharmacy Brand purchases have a satisfaction guarantee policy?
- A. Yes, all CVS Pharmacy Brand products are 100% satisfaction guaranteed or your money back. If you're dissatisfied for any reason, you can return the CVS Pharmacy Brand product (opened or unopened) along with your receipt or invoice to any CVS Pharmacy store.

#### Q. What is the ExtraCare® Health Card?

- A. The ExtraCare Health Card is a program from CVS Caremark® and your employer that allows you to save money online at CVS.com or throughout any CVS Pharmacy® store. Your card entitles you to receive the following:
  - 20% savings\* on thousands of regularly priced CVS Pharmacy Brand health-related items valued at \$1 or more
  - Special weekly savings on items throughout the store
  - ExtraBucks<sup>®</sup> Rewards. Earn 2% back and more towards ExtraBucks Rewards on all purchases<sup>1</sup>
  - Personalized coupons just for you

#### Q. Where can I use it?

- A. You can use the card at any CVS Pharmacy location or online at www.cvs.com. Your ExtraCare Health Card may not be used in Target stores including those with a CVS Pharmacy in them.
- Q. Do I have to pay for the card to receive all of these savings?
- A. No. It is provided at no cost to you.

#### Q. What if I lose my card?

A. When you receive your card, be sure to write down the phone number on the back and keep it in a safe place. Then, if you lose your card, simply call the number and a new one will be issued.

#### Q. Does the card expire?

A. If you change employers, or if your employer changes prescription benefit managers, your card will no longer give you a 20% savings on health-related items. However, you can still use it to get the same benefits as a regular CVS Pharmacy ExtraCare Card.
